Call to Order

Approval of Minutes

- Duke Summers was nominated and seconded to KRA Chair and Laura Beth Barton was nominated and seconded to Vice Chair. Both were voted in unanimously.

Public Comment

- Jennifer Trosper addressed the board with a question regarding the trash and cigarette butts found on playground on Mexeye Loop. Tracey Mueller said she was pretty sure smoking was not allowed on the playground and was surprised there was no "No Smoking" sign visible at the playground. She said she would look into the situation.
