16 calls for outside agency assistance were requested off tribal lands and occurred on Libby McClain Highway, along our property line, Cape Arago Highway, Coos Bay/North Bend and the Charleston area. When requested to assist other agencies, it involves Officer Safety Concerns, a Felony Crime in Progress or Major Traffic Accident.

We have had 14 Traffic Stops that have occurred in various areas, Tribal Housing, Cape Arago Highway, Libby McClain Highway as we are checking our North Parcel and Coos Bay/North Bend as we are driving to our Administration Building and The Mill.
