#### **Companion Animals on Tribal Lands**

Christmas can be a popular time to surprise your child or family with a new puppy or kitten. However, pets are NOT allowed on Tribal Lands in rental units.



Companion animals are allowed, but a doctor's prescription must be provided to and verified by CIHA PRIOR to adding a companion animal to your household. The animal will be required to be spayed or neutered and up-todate on ALL vaccinations; no exceptions.
