Just a reminder that per CIHA's Common Scheme Restriction Policy, "All parking, other than in the driveway or garage, must be on the side of the street where the streetlights are and must NOT exceed 24 hours."

Also, "No tent structure, camper, recreational vehicle, motorcycle, trail bike, snowmobile, boat, trailer, motor coach, or mobile home, or any structure of any kind shall be parked, placed, erected, or used upon the property."

BEWARE of Text Message Links - Potential Scam Targeting SNAP Participants

Oregon Department of Human Services (ODHS) has received reports of a potential scam targeting SNAP participants. The *scam came in the form of a text message*, which asks the person to click on a link, telling the customer they will lose their SNAP benefits because they haven't used them. Text reads: "You have not availed your Dec Food Stamps. Go here [fraudulent link] before they expire."

- * **Don't click on text message links.** The links can take you to spoof sites that look real, but will steal your personal information.
- * **Never share your personal information** with individuals or organizations that you do not know. Personal information includes, but is not limited to, your social security number, banking information, SNAP EBT card, and PIN numbers.
