This is a limited-time opportunity for low to moderate income Coquille Tribal homeowners residing in Coos County to install a high efficiency ductless heat pump at a discounted rate and lower your utility bills. Ductless heating systems use 25-50% less energy than traditional heating systems, *provide both heating and cooling*, and are simple to install and operate.

To qualify for the discount of \$450-\$900 **plus a \$1,500 Tribal incentive**, join a free online workshop and learn more about ductless heat pumps, as well as additional incentives and rebates available through Energy Trust and your electric utility.

**A: To qualify for the extra \$1,500 Coquille Tribal incentive, you must**

- Be a Coquille Tribal member
- Reside in Coos County
- Own your home
- Attend an Energize South Coast workshop
- Install a ductless heat pump through the 2021-2022 Energize South Coast program
- Have a household income equal to or below 100% of HUD Area Median Income

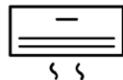

- Proof of Tribal enrollment
  - Documentation of household income (2020 federal tax return, pay stubs, bank statements, etc.)

**Q: What else should I know?**

- A:**
- Only six \$1,500 Tribal incentives are available and will be distributed on a first come, first served basis.**
  - Submit your signed installation contract to receive an incentive voucher to provide to Pacific Air Comfort.
  - Your incentive will be paid directly to Pacific Air Comfort upon completion of installation.
