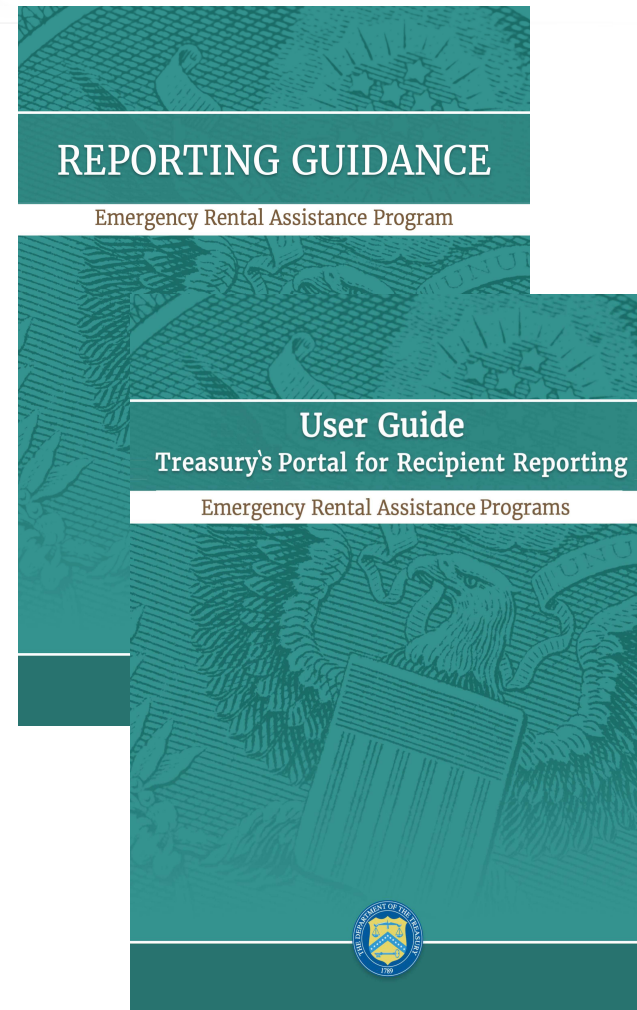

Overview of Reporting Elements

Recipient Profile

- This information will be pre-populated with data from your ERA application and other sources.

Participant Counts and Demographic Data

- Details on number of participants served including number of applications received and accepted, amounts of ERA funds paid for rent, rent arrears, utility/home energy costs and arrears, housing stability services, administrative costs, etc.

Financial Information

- Such information as amounts of ERA program funds obligated and expended including when funds were disbursed, who received funds, and other key information.

Federal Financial Reporting (SF-425 Form)
