Call to Order

Approval of Minutes

Old Business

- Emergency Preparedness Laurabeth discussed her current talks with Chief Merritt and Lon Matheny regarding emergency procedures on Kilkich. Chief Merritt mentioned the Nixel app for notifying residents of an emergency. He also brought up the possibility of a grant that might pay for signage or a digital message board to alert residents of problem situations. Residents will be encouraged to get Nixel.
- Kilkich Forest Brady told the board that the Forest Service has been working with a disease resistant Port Orford Cedar that they would like to test in areas where cedars have died. They have offered 1,000 seedlings to be planted on Kilkich.
- Kilkich Days The Board would like to move ahead with planning for a celebration sometime late in July of this year. Since it has been decided that this year's Restoration will be an in-person event, KRA will probably be able to have a Silent Auction. Shelley has donated many items from Toni Ann's estate and has offered to help with the Auction.

New Business

- Community Solar/Common Energy A webinar is tentatively set for Wednesday, February 23rd, 12:15 p.m.– 1:00 p.m. Anne said she would confirm the date as soon as possible. While there is no Solar Farm yet for us to sign up for, we are encouraged to attend the webinar and sign up for future savings.
- Playground and Dog Park These items may be included in an upcoming Master Plan the Tribe is currently working on. We discussed the fact that a fence or barrier of some kind would be helpful to keep children out of the road.

- Chief Jerry Merritt informed the Board that a grant to replace some of the gravel on the road up to the Cemetery had been approved and low areas of gravel would be fixed.
