Call to Order

• Chair Laurabeth Barton called the meeting to order at 5:32 p.m. via ZOOM.

CIHA staff Tracey Mueller, Tribal Police Chief Jerry Merritt, Tribal Events Coordinator Nicole Howe, and Kilkich residents Jessica Meza, Shelley Estes, and Lon Matheny were also present.

Approval of Minutes

Old Business

- Emergency Preparedness Laurabeth and Rocky reported that they attended a Council Workshop that simulated a winter storm emergency that highlighted the importance of establishing a reliable way to contact residents in the case of an emergency. He is intending to ask CIHA to put this issue on their Agenda as well. The app Nixel might be the most effective and is currently used by the Tribe, but we currently do not know who is registered. KRA Board members may walk the rez and knock on doors to encourage sign ups and to discuss the importance of preparedness. Lon told us that Mike Frost and Jessica Hamner are working on finding an incentive for signing up and he asked that when we speak to residents, we find out who needs special accommodation during an emergency such as oxygen. He also mentioned that Clark might have the information regarding who is signed up for Nixel.
- Kilkich Forest Laurabeth said she had not heard anything from Council regarding the name of the Forest. She did say that when they start to clear back the forest for fire prevention, we will be informed. Brady said he the Natural Resources committee have

found that changing the name from Empire Forest to Kilkich has become a more complex and frustrating issue.

- Kilkich Days and Restoration Due to lack of funds we decided to wait to select a date. Pam said she would email Nicole regarding the Auction and use of a table. Rocky also said that Jessica Hamner might have funds available for Kilkich Days if we can somehow work in emergency preparedness. Pam mentioned the Silent Auction and the fact that she may not be available. Laurabeth said current plans may not have available space at Restoration for an Auction. Pam agreed to contact Nicole regarding a table and Rocky agreed to ask Nick if he might be able to help us work up an online Auction so we would not have to request space at Restoration. Pam asked if Shelley was still interested in helping at the Auction and maybe photographing items. She agreed.
- Signage for the dumpsters and recycle bin was discussed. Tracey said she was checking with Les's to find out if they had any signage we might use and if not we would be able to have her make laminated signs similar to those we have used for our past events. Rocky asked Tracey if she could mention in Sea~Ha Runner that the trash pick-up had been changed from late Sunday to early Monday morning. She said she would be glad to add it to the Runner.
