# **Approval of Minutes**

### Amendments to Agenda

• It was agreed that Fauna and Matt would present their overview of the road construction before the Treasurer's Report.

#### New Construction on Kilkich

- Fauna presented the Board with a handout showing the existing conditions and a page showing the phased construction as well as the competed project. See attached.
- Starting May 18<sup>th</sup>, the bogs will be cleared out so that clean dirt may be moved there as needed during the road construction. The parking lot at the Head Start/Learning Center will be enlarged in addition to changing the intersection of Mexeye Loop and Miluk Dr. There are also plans for a sidewalk to be added from Cape Arago Hwy to the road that leads to the apartments. The project is slated to end by the end of September. We were asked for suggestions for informing residents of the changes. It was agreed that flyers would be placed on resident doors with information and contact numbers as well as instructions for signing up for electronic notifications of traffic changes. Noise and sound abatement were also discussed. Construction trucks will not start until 7 a.m. Fauna will have her contact info available to residents and Rocky offered to have his phone number listed as a representative of KRA to answer questions. At next month's meeting Fauna and Matt will return with any updates and will bring food in hopes of encouraging residents to attend. KRA will create a flyer inviting residents and post on doors.
