RESOLUTION CY23084

APPOINTING TWO MEMBERS TO THE COQUILLE INDIAN HOUSING AUTHORITY BOARD OF COMMISSIONERS

- WHEREAS, the Coquille Indian Tribe ("Tribe") is a federally recognized Indian tribe pursuant to the Coquille Indian Restoration Act of June 28, 1989, 25 U.S.C. § 715, et seq. ("the Act"); AND
- WHEREAS, the Coquille Indian Tribe is governed by the Coquille Tribal Council pursuant to the Tribal Constitution adopted by eligible voters of the Tribe on August 27, 1991, and approved by the Secretary of the Interior on September 9, 1991; and that the Tribal Council is empowered to act for the Coquille Indian Tribe; AND
- WHEREAS, the Tribe has formed the Coquille Indian Housing Authority ("CIHA") under Tribal law to, among other things, serve as its Tribally Designated Housing Entity; AND
- WHEREAS, CIHA is governed by a Tribal Council-appointed Board of Commissioners; AND
- **WHEREAS**, positions #5 and #6 on the CIHA Board of Commissioners are currently due for appointment; AND
- **WHEREAS**, the CIHA Board of Commissioners solicited applications for these prospective appointments, has reviewed all applications received, and now recommends candidates to fill these CIHA Board of Commissioner positions; AND

WHEREAS, the Tribal Council wishes to appoint individuals to serve in these positions; NOW

THEREFORE, BE IT RESOLVED, that the Tribal Council appoints Donald Garrett to serve an additional term on the CIHA Board of Commissioners in Position #5, which will expire April 30, 2026; AND

THEREFORE, BE IT FURTHER RESOLVED, that the Tribal Council appoints Robert More to serve an additional term on the CIHA Board of Commissioners in Position #6, which will expire April 30, 2026; AND

THEREFORE, BE IT FINALLY RESOLVED, that the Tribal Council Chairperson, or in her absence or unavailability, the Tribal Council Vice Chairperson, is authorized to sign any documents necessary to give this resolution full force and effect.
