Call to Order

• Chair Shelley Estes called the meeting to order at 5:31 p.m. in person at the CIHA office and on Zoom.

CIHA staff member Tracey Mueller attended via Zoom. CIHA staff member Anne Cook joined the meeting in progress at the CIHA office.

Approval of Minutes

Old Business

- R U Ready? Disaster Preparedness Book It was agreed that KRA would not work on an update to the R U Ready? Book because people can access the same information online now. Lon and Jessica will be invited back periodically to provide updates on community preparedness.
- KRA Haunted Woods Due to weather concerns, it was decided to have the event in the community plankhouse. A reservation request was sent to Nicole Howe. Alison agreed to follow up on reservation status. Pam has had numerous events working with children and agreed to help Shelley with planning.

• KRA Coffee & Cocoa with a Cop, December 2, 2023 – The event may be postponed until Chief of Police Merritt returns to work. Alison was authorized to purchase a get-well gift for Chief Merritt with up to \$50 in KRA funds. Rocky will add up to another \$50 personally if the item selected costs more.

New Business

- New Bank Account and Funds Draft KRA Accounting Guidelines were prepared by Marcy Chytka and Anne Cook. The guidelines will help ensure that KRA accounting activities and records are well managed and will offer the Treasurer adequate guidance to support KRA's new bank account. It was unanimously agreed to adopt the new KRA Accounting Guidelines.

Public Comment

• Sheldon asked about fundraising activities. KRA's main fundraisers are a silent auction and blanket raffle at the Tribal Restoration Celebration and a blanket raffle and 50/50 drawing at the Winter Gathering. The Board liked the idea of requesting donations of new or like new items for a garage sale in August, silent auctions, and to sell on the Kilkich Facebook page. KRA would also like to request small donations from the Tribe and apply for a Tribal Community Fund grant. Funds would be used to sponsor community activities like bowling, a food truck at the Wellness Center, winter dinner with a speaker, movie night, bingo, etc. to reduce isolation and support mental health. Alison will put together a plan for a winter dinner event and Pam will apply for a donation from the Tribe to cover the cost.
