Join in the fun on **Wednesday, July 3rd**, for the annual **Blast by the Bay!** You won't want to miss one of the **Oregon Coast's largest fireworks displays.** Fireworks will be simulcast on **K-DOCK 92.9 FM.** Shuttle service is available to and from **Pony Village Mall** from **7 PM - 12 AM.** Shuttle pick up/drop off location will be at the south end between the **Mall and Pony Village Cinemas.**

The Coquille Indian Tribe announces the sponsorship of the **Summer Food Program** for eligible applicants at the Tribal Community Center.

Breakfast and lunches will be made available Monday through Friday free to all children residing on the reservation 18 years of age and under. Meals will be served at the Tribal Community Center beginning June 17, 2024.

Mealtimes will be 8:30 a.m. for breakfast and 11:30 a.m. for lunch.

**Coquille Tribal Ordinance 650.620 states that “a person commits a fireworks violation if the person sells or uses fireworks within the lands of the Tribe, except as hereby provided:**

1. Only those fireworks allowed by the State of Oregon are approved for use on Tribal Lands.
2. Fireworks may only be ignited during the 48 hours before the official holiday and for 24 hours after.
3. Official holidays during which fireworks may be ignited are the 4th of July and New Years Day.
4. Any person under the age of eighteen must have the immediate supervision of an adult.
5. Improper or unsafe use will result in the confiscation of all fireworks in the possession of the person by Tribal Police.
6. Tribal officials may make subsequent restrictions on the use of fireworks based on public safety, weather conditions, and fire concerns.

In addition, and not in lieu of any other penalty allowed by law, a \$50 assessment shall be paid to the Coquille Indian Housing Authority by any person found in violation of this ordinance.”

Keep your pet safely away from fireworks. Pets are more sensitive to loud noises, flashing lights, and strong smells. On the Fourth of July, and other days people are likely to set off fireworks, it's best to leave your pets safely indoors, preferably with a radio or TV turned on to soften jarring noises. If your pet is scared by fireworks, ask a veterinarian for help.
