## **Kilkich Exterior Painting:**

- 704 Jistajaya Court 101 Home Care replaced rotten window trim 8/5-8/24. McCormick & Son Construction painted exterior of unit 8/12-14/24. New gutters installed 8/26/24.
- 2650 Mexeye Loop Jenson Family Construction painted exterior 7/29/24-8/9/24. Began emergency repairs on south wall 7/29/24 after discovering rotten window framing while replacing window trim. Completed framing repairs and siding and trim replacement 8/7/24. New gutters installed 8/26/24.

Blueprints and specs delivered to HGE 5/30/24. Received preliminary floor plan and elevations from architect on 7/17/24. LM and SP met with architect 8/15/24 for building site walkthrough and to discuss corrections to plans.

- 708 Demo began 9/29/23. All demo completed 11/2/23. Colonial Concrete Construction performed grade corrections to sidewalks and driveway.

Colonial Concrete Construction demoed existing driveway and sidewalks and excavated foundation for addition, sidewalk, and driveway, and to correct driveway grade issue. Set forms, spread, and compacted gravel and installed chairs, rebar, and wire mesh 10/24/23. Poured concrete 11/17/23. Framing and dry-in of addition 12/11/23-1/23/24 as weather permitted. Drywall, texture, interior and exterior paint weeks of 1/29/24-4/12/24. Flooring, doors cabinets, interior finishes, decks, ramps, and handrails weeks of 4/15/24-5/22/24. HVAC installation 5/1-2/24. Wheeler Excavating regraded yard to bring grade up to meet the new sidewalk and driveway week of 5/23-30/24. Installed kitchen counters, bath counters, final plumbing and electrical week of 6/17-21/24. Site cleanup and cleaning week of 6/24-28/24. Finishes and touch ups performed 7/12-16/24. 2651 Rehabilitation – Demo began 9/21/23. Demo completed 10/24/23. Extensive termite damage discovered during demo. Unit treated for termites 9/27-29/23, 10/23/23, and exterior treatment 10/27/23. Termite damaged framing replaced weeks of 10/23/23-12/1/23. Colonial Concrete Construction performed grade corrections to sidewalks and driveway. Excavated for addition, set forms, spread, and compacted gravel and installed chairs, rebar, and wire mesh 11/2-28/23. New concrete poured 12/11/23. New siding installed because of reframed exterior walls from termite damage and framing of interior walls week of 12/18/23-12/22/23. Framing and dry-in of addition weeks of 12/29/23-2/22/24 weather permitting. Installed insulation in exterior walls from reframe caused by termite damage 2/29/24-3/1/24. Primed and painted exterior 3/14-18/24. Drywall, texture, and paint interior weeks of 4/1/24-5/21/24. Wheeler Excavating performed work to regrade yard to bring grade up to meet the new sidewalk and driveway week of 5/23-30/24. HVAC installation 5/28-29/24. A tree service company will be scheduled for any hand cutting needed.

- Delivery of solar panels and equipment 9/22/23. Installation began 10/2/23. All labels, stickers and electrical work finished 11/22/23. Electrical inspection passed on 11/22/23. Final structural inspection passed 12/4/23. Net Meter installed by Pacific Power 5/15/24. Contractor walkthrough with Energy Trust of Oregon on 7/22/24. CIHA and contractor walkthrough with Oregon Department of Energy 8/15/24.

## Signs:

• Welcome sign – Contractor removed sign 4/12/24. Sanded and refinished main part of sign, repainted lettering and reinstalled on 5/13/24. Contacted Signcraft 8/29/24 to start emblem redesign to replacement.

# **Mailbox Shelter Replacement:**
